



## CALL FOR NOMINEES

Since its creation in 1989, the Pennsylvania Association of Community Bankers' Hall of Fame has recognized men and women who have significantly contributed to their community, institution, and in particular, this Association, and are now retiring or have recently retired from community banking. If you know someone like this, PACB would like to include him/her among the outstanding individuals who have already been inducted.

The Hall of Fame consists of dedicated community bankers who have been honored for their faithful service and genuine concern for Pennsylvania's communities. To be considered for membership in this elite group, a candidate must meet the nominating criteria and then be nominated. Candidates selected for induction are also subject to final approval by the PACB Executive Committee and Board of Directors. Those individuals chosen as 2020 inductees will be inducted at the PACB Annual Meeting (Friday, September 25, 2020) and recognized at the Gala Dinner (Saturday, September 26, 2020) to be held during PACB Convention 2020 at *Disney's Grand Floridian* Resort & Spa in Lake Buena Vista, Florida.

Please discuss potential nominees among your executive officers and/or board members and submit his/her name and a biography to PACB by May 4, 2020.

The strength of the Pennsylvania Association of Community Bankers is, and will always be, the leaders of our institutions. It is only fitting to honor these distinguished individuals through the PACB Hall of Fame.

## Nominating Criteria

To qualify as an inductee into the PACB Hall of Fame, nominees must meet the following criteria:

- Must be a current or former member of PACB before retirement.
- Must be retired, or scheduled to retire, by the Annual Membership Meeting to be held on Friday, September 25, 2020.
- Must be, or has been, in senior management at his/her institution.
- Must have made a significant contribution of time, energy, commitment and service to his/her community, institution and PACB (or its predecessors, PASI or CBP).
- Must have served at least seven (7) years on either the PACB (or its predecessors) Board of Directors, Executive Committee or any of its standing committees.
- Must be nominated by a PACB member in good standing.
- Must be approved by the PACB Executive Committee.

The PACB Board of Directors will give final approval of nominees at the June 16, 2020 Board of Directors Meeting.
